

Dynamic Compression Workshop held at APS June 23 and 24

- The goal of the Workshop is to see how the APS can be utilized to examine and understand the real time response of dynamically compressed materials at the microscopic level.
- To be discussed in this workshop are fundamental scientific challenges and technology needs to study condensed matter under dynamic compression, including:
 - EOS, melting, and other phase transitions
 - Deformation, fracture, and microstructures
 - Electronic structures, chemical bondings, and reactions
 - Kinetics, metastabilities, and supercooled/heated solids far from equilibrium
 - New technology developments for shock and shockless compression
 - Enabling national facilities for real-time structural studies
- This group is interested in developing at CAT at the APS for these studies. So far they have submitted a letter of intent (LOI), which has been sent out for peer review.
