Safety Issue "Abrasive Cut Off Saw" Thumb Injury

- Worker was using an Pistorius abrasive cut off saw to cut bolts from two small plates.
- Saw uses a thin grinding wheel rotating at 1750 RPM with water jets to cool/clean wheel edge and item being cut.
- Wheels are brittle and easily break.
- Saw has machine guarding designed to direct fragments straight downwards.
- This was a "home project" and not authorized work.






Thumb Injury cont'd

- Worker was holding one piece where his thumb was near the wheel and exposed.
- Worker inadvertently tilted piece when one bolt was cut through and then wheel contacted a second bolt – this placed lateral force on the wheel.
- Wheel shattered and a fragment struck worker's thumb with enough force to split the skin and nail as well as break the bone in the thumb's tip.





Wheel Fragment

Wheel shattered leaving support mandrel in place.



Actions Taken

- Saw was examined and all machine guarding was properly in place.
- Counted as a "serious injury" and had to be formally reported to DOE.
- Saw operating manual obtained and safe operating practice will be demonstrated to other workers who use these saws.
- Argonne's Chief Operations Officer issued a memorandum to all Division Directors and Department Heads reminding them of Laboratory policy regarding use of equipment only for authorized work.
 - Incidental use of phone and computers allowed.
 - Policy also applies to all resident and non-resident users and non-ANL owned equipment which is located at the ANL site. Notice will go out in User news.




APS General
